AGREEMENTS, TERMS AND CONDITIONS

1. The undersigned (The Customer) may desire to purchase goods from the Company on account and agrees in consideration of the account to be bound by the following terms and conditions.
2. Everything contained in this Application and any other information furnished by Customer or Guarantor(s) for use in connection with or related to this Master Credit Application and Agreement is true and correct to the best knowledge of the undersigned and Guarantor(s). It is understood the Company will retain this application whether or not it is approved. The Company is authorized to check credit, bank and trade references and/or credit reporting agencies to obtain answers about credit of Customer and/or Proprietors prior to becoming Guarantor(s).
3. Company agrees to pay any and all invoices, charges, fees and costs which Customer or any authorized person incurs, on Customer's account.
4. Company's terms are Net 30. All sums past due shall bear a service charge at the rate of one and one half percent (1.5%) per month.
5. If Company is not paid on time, in accordance with Company's terms, Customer shall pay for all costs and expenses incurred by Company in connection with Company's attempts to obtain payment, including fees charged by a collection agency or attorney, and any other charges which can be legally charged to Customer. Customer agrees that for and in consideration of Company's extension of credit, that this Agreement is to be construed under the laws of the State of Arizona, and that if legal action is brought to enforce this Agreement, that the Superior Court for the State of Arizona Maricopa County, or the Dreamy Draw Justice Court, Maricopa Arizona shall be the exclusive jurisdiction and legal venue for said action. If Company refers this agreement to an attorney for enforcement, including collection of amounts which are past due, Customer agrees to pay Company's actual attorney's fees and costs incurred thereby, whether or not formal proceedings are brought to remedy Customer's breach of this agreement. Customer agrees to pay Company a \$25 service charge on each dishonored check returned to Company.

The undersigned hereby agrees to the terms and conditions of the agreement as binding on the Customer whether individual, partnership, corporation or other. The undersigned further declares to the Company that I am duly authorized to sign this Master Credit Application and Agreement form on behalf of Customer.
